RELEASE OF LIABILITY AND CONSENT TO EMERGENCY MEDICAL TREATMENT

I the undersigned parent/guardian of _____, do hereby consent that he be permitted to attend the above mentioned field trip; and should the need arise, do hereby authorize and consent to any emergency x-ray, examination, anesthetic, medical or surgical diagnosis and treatment rendered under the supervision of any member of the medical or emergency room staff. It is understood that this authorization is given in advance of any specific diagnosis or treatment or care and is given to provide authority and power to render any care, which the emergency medical provider may deem advisable. It is understood that an effort shall be made to contact the undersigned parent/guardian and emergency contact prior to any services being rendered, but that any of the above treatments will not be withheld if the undersigned and the emergency contact cannot be reached. I will not hold Young Man With A Plan or its chaperones liable for medical aid rendered and will be responsible for any medical costs that may be incurred as a result of emergency medical care for my son/ward.

In order that my son/ward may receive the necessary medical treatment, I hereby hold Young Man With A Plan and its representatives harmless in the exercise of this authority.
